#### National Day to Prevent Teen Pregnancy



May 2 was the National Day to Prevent Teen Pregnancy, organized by the National Campaign to Prevent Teen and Unplanned Pregnancy and observed each year in May.

Nearly 40% of teens aged 14 to 17 are using digital technologies to seek out health related information, including information on sexual health. In response, a growing number of sexual health organizations are creating online and Smartphone-based tools

aimed at providing reliable information and helping teens and young people prevent unintended pregnancy.

-to source for accurate
information about
contraception, pregnancy
prevention, and staying
healthy in general, Planned
Parenthood's new Tumblr
presence puts helpful,
current, and engaging
information in front of its
followers on a daily basis and
allows them to share it easily
with their own online circles.

The National
Campaign to Prevent Teen
and Unplanned Pregnancy
has also produced an online
tool to help women avoid
unplanned pregnancy: the
organization's <u>Bedsider</u> tool
is an online birth control
support network for women
18-29, with the goal of
helping women find the
method of birth control that's
right for them and learn how
to use it consistently and
effectively.

#### North Dakotan's Against Measure 3

While we are gearing up for a fun-filled primary election on June 5, across the border in North Dakota, they plan to vote on "sincerely held religious beliefs."

I try to keep an eye on ballot measures in other states, because there's always a chance we'll see them end up in South Dakota. And you know how we love our ballot measures!

North Dakota will vote on June 12 on four different ballot initiatives including Measure 3 which aims to change the ND State Constitution. The North Dakota Family Alliance and the ND Catholic

Conference are supporting the measure that they claim will protect against discriminations against sincerely held religious beliefs.

If you think this sounds familiar, you're right. Long before the Blunt Amendment in February 2012, which would have allowed employers the option of not covering contraceptives if they were against their religious beliefs, North Dakota was planning to expand that idea.

Opponents of Measure 3, a coalition of legal and medical professionals, religious leaders, and concerned citizens called North Dakotans Against Measure 3, are worried about the unintended consequences of passing a change like this. From their website, "The language in this law is too broad, poorly written, confusing and has so many loopholes that it can open the door for serious and even harmful unintended consequences for all North Dakotans. In the real world, we all know that some people take advantage. Measure 3 could cause real harm to some of our most vulnerable citizens."

It will be an interesting result to watch.

#### National Women's Health Week

May 13-19 is National Women's Health Week, a time when women are encouraged to prioritize their health and schedule wellness checkups that include lifesaving preventive health screenings.

National Women's Health Week is coordinated by the U.S. Department of Health and Human Services'

Office on Women's Health, and brings together communities, businesses, government, health organizations like the Ovarian Cancer National Alliance and the National Healthy Mothers, Healthy Babies Coalition, and other groups in an effort to promote women's health.

Last year alone, Planned Parenthood provided nearly

750,000 breast exams, birth control for more than 2 million people, 770,000 Pap tests, and more than 4 million tests and treatment for STDs.

that she plans to step-down
at the end of 2012. Keenan
took the reigns for the organization in December of
2004 and immediately
showed proficient leadership. In 2006, she made
Washingtonian Magazine's
list of the top 100 most
powerful women in Washington.

Keenan stated in an interview with the Washington Post that her decision to leave was in part out of concern for the future of the pro-choice movement, and that she could be holding it back. She expressed a belief that there is an opportunity for a new, young leader for NARAL Pro-Choice America, someone who can lead the movement for decades to come. As we approach the 40th Anniversary of the

Roe v. Wade decision,
Keenan believes it is time for
her generation to step out of
the way and let those of the
Millennial generation step
into leadership roles.

As a young woman in the movement, I give my sincere thanks to Nancy for her years of inspiring leadership and for her efforts to create space for my generation in the pro-choice movement.


man" (inspired by Rush Limbaugh).

# Representative Noem's Latest Insult to Women

When it comes to violence, Native American women are the most vulnerable group; nearly half of all Native women are subject to rape, physical violence, or stalking by a domestic partner at some point in their lives, according to the Centers for Disease Control.

Add "political assault" to that list.

Congresswoman Kristi Noem's recent comments regarding the Violence Against Women's Act was like a verbal gut-punch to Native women in South Dakota and across the nation.

Here's the background: In April, the U.S. Senate reau-

thorized an expanded version of VAWA, which included new language allowing tribes to prosecute non-Native attackers.

That's a pretty big deal considering the U.S. Department of Justice estimates 70% of the perpetrators of violence against Native women are non-Native. As it is, tribal councils have no authority to prosecute non-Native individuals on domestic assault charges, even if the perpetrators live on reservation land.

Coupled with the Senate bill's other protections for LGBT and immigrant survivors of domestic abuse, Rep. Noem dismissed these important provisions as nothing more than a vote-fishing scheme by Democrats. "Unfortunately, in Congress there are some who'd like to make this a political play," Noem said. "They'd like to make a cheap shot and try to politicize it in an election year."

Noem's statement – and the flaccid counter-bill House Republicans want to pass - will leave a lasting mark on Native women and families if left untended.

I am Mniconjou Lakota from Cheyenne River. I have seen first-hand how prevalent domestic violence and sexual assault are on reservations. I have worked with Native mothers who say they teach their daughters how not to be raped.
Got that? The lesson isn't finding someone who loves and respects you, but rather avoiding a drunken partner or dodging attacks.

It utterly flabbergasts me how an elected official like Noem can claim to represent Native women and families, yet turn her back on the remedy intended to heal one of Indian Country's most troubling sores.
